*I am the founder of Police Weapons Training & Consulting, a retired Detective and instructor at the New York City Police Department Firearms & Tactics Section (FTS). I was a member of the Curriculum Development Unit within the Training Coordinator's Office. In nearly twelve years at FTS I spent more than half of that time developing curriculum, training other instructors, and handling special projects. In addition to personally training thousands of NYPD officers in the safe and proficient use of firearms I also qualified over 1,000 NYPD officers in the use of Oleoresin Capsicum (OC/pepper) spray and Conducted Electrical Weapons (Tasers). I similarly conducted Reality Based Training, and simulator-based training for over 1,000 NYPD officers, I certified over 800 instructor applicants as firearms, Taser, Pepper Spray, Reality Based Training, Simunition and Ti use of force simulator, instructors. Lesson plans I have written have been used to train tens of thousands of police officers, and I am NY State and Manufacturer certified as an instructor, or master instructor in numerous force options.*

### Scope of Work:

- Testified multiple times in NYS criminal and civil courts, and a department trial. Recognized by various courts as a subject matter expert in Tasers, Pepper Spray, use of force, police training, firearms, police tactics, and police procedures. I have also been consulted as a subject matter expert by over a dozen international, Federal, State, and local agencies.
- Authored or revised key lesson plans which have been delivered to tens of thousands NYPD officers of all ranks. Notable amongst them: Use of OC Spray; Use of Force; numerous In-Service Pistol Qualification Cycles; Advanced Tactical Leadership; X26P CEW End User; Taser 7 CEW Operator; Patrol Tactics; Tactical Training Centers; FTS Overview; much of the recruit training curriculum; and others.
- As a firearms instructor and a master instructor in Tasers, OC Spray, Reality Based Training, Simunition, and the Ti Force Option Simulator, I have been the course director and lead trainer responsible for certifying hundreds of fellow departmental instructors in various manufacturer, State, and departmental certifications.
- One of two FTS instructors sent to the Hashemite Kingdom of Jordan to assess their police training facilities, equipment and curricula. I developed a "train the trainer" curriculum



and returned to Jordan to conduct a three-week course, which was met very favorably by the head of the Jordanian Public Security Directorate, and improved relations between the Kingdom and the NYPD Intelligence Bureau.

- Represented the NYPD at several meetings of the New York State Division of Criminal Justice Services' (DCJS) curriculum enhancement panel focused on updating the statewide Basic Course for Police Officers initial firearms course. This curriculum was approved by the NYS Municipal Police Training Council (MPTC) to formulate the new statewide recruit firearms training standard. Additionally, I also represented the NYPD in crafting a five-day instructor workshop to certify existing instructors to present the new curriculum. I was also one of two NYPD representatives on a DCJS panel that overhauled and modernized NYS Firearms Instructor training which received MPTC approval and went into effect December of 2024.

- Conducted Use of Force orientation and simulator-based training for civilians. In total I conducted this sort of training in at least 100 instances, with a total of over 3,400 participants between 2018-2024. This includes employees of the Kings, Queens, New York, and Bronx District Attorney's office (at least 40 instances, with a total of over 1,000 participants).

- Took the lead on many important Special Projects, such as being exposed to four different personal defense sprays to test them and then presenting a report to the NYPD Uniform Equipment Committee, which was accepted. In 2025, all NYPD officers were issued a new type of pepper spray due to my testing and efforts.
